PROVISION OF INTEGRATED FOOTBALL MATCHDAY TICKETING AND REVENUE COLLECTION SERVICES

- The Tanzania Football Federation invites sealed technical and financial proposals from eligible and qualified firms to provide, implement, operate and support an integrated football matchday ticketing and revenue collection service for competitions and matches administered or supervised by TFF and TPLB.
- The assignment includes digital ticket sales, payment integration, ticket validation and access control, matchday operations, revenue reconciliation, real-time reporting, cybersecurity, customer support, training and orderly system handover. All gross ticket proceeds shall settle directly into a bank or collection account designated and controlled by TFF.
- The intended contract period is four football seasons, from 2026/27 to 2029/30, subject to annual performance review and the terms of the resulting contract.
- Interested firms should demonstrate the following minimum capacity:
 - Legal registration, a current business licence and applicable tax compliance;
 - Proven experience in comparable digital ticketing, payment collection or large-event access-control assignments;
 - Secure and auditable ticketing technology capable of mobile money and card integration, online and offline validation, real-time reporting and revenue reconciliation;
 - Qualified technical, ticketing operations, payments, cybersecurity, marketing and customer-support personnel; and
 - Financial and operational capacity to deploy equipment and support matchday operations in Tanzania.
- A service provider will be selected using Quality and Cost Based Selection (QCBS), with technical and financial weights of 80 percent and 20 percent respectively, in accordance with the TFF Procurement Manual 2017 and applicable TFF and FIFA requirements.

- Requests for clarification must be submitted in writing to tanfootball@tff.or.tz no later than **14:00 hours East Africa Time on 19 September 2026** TFF will issue final clarifications or any addendum by **20 September 2026**.
- Proposals must comprise one signed original and four copies of the Technical Proposal, one signed original Financial Proposal, and one searchable electronic copy of the Technical Proposal on encrypted media. The Technical and Financial Proposals must be placed in separate sealed envelopes and enclosed in one sealed outer envelope clearly marked:

- Proposals must be delivered to the Secretary, TFF Tender Committee, Tanzania Football Federation, Karume Memorial Stadium, Uhuru Street and Shaurimoyo Road, P. O. Box 1574, Dar es Salaam, no later than **14:00 hours East Africa Time on 22 September 2026**. Technical Proposals will be opened immediately thereafter in the presence of proposers' representatives who choose to attend.
- Late proposals and proposals submitted electronically will not be accepted. TFF reserves the right to accept or reject any proposal, or cancel the procurement process before contract signature, in accordance with the applicable TFF procurement procedures.
